Trustee Sangster moved to approve the Requests for Credit Approval as amended. Trustee Hoffman seconded the motion and all voted in favor.

7. Discussion and possible action regarding "Resolution Authorizing Sale or Disposal of School Property"

Pursuant to 20-6-604 MCA, the local school boards must approve the sale or disposal of school property. Vannesa sent an email to principals and directors requesting items for disposal. They are listed on Exhibit A along with the Resolution Authorizing Sale or Disposal of School Property. The revenue from the sale of any items will be placed in the Building Fund #260.

The Resolution would become effective October 3, 2016, to dispose of the items presented.

Mr. Bowen stated that the sale of items would be on October 20th and or the 21st (non-student attendance days). The public would be notified and the process would be like a sidewalk sale.

Trustee Wolsky moved to sell and/or dispose of the items presented, and to appropriate the revenue earnings from any sales to the Building Fund.

Trustee Harder-Brouwer seconded the motion and all voted in favor.

8. Policy 3145 Foreign Exchange Students

Corvallis has a long history of support in accepting foreign exchange students into our high school. Policy 3145 in its current form doesn't reflect the flexibility or articulate the intent of the board and administration. The proposed language articulates the intent and flexibility needed to address the number of foreign exchange students that may want to attend Corvallis High School while maintaining board oversight and control beyond the 1% of CHS enrollment.

General discussion took place regarding the effect of the changes. Mr. Wirt stated that he was comfortable with the changes being presented for approval.

Trustee Wolsky moved to approve Policy 3145 on second reading. Trustee Channer seconded the motion and all voted in favor.
